Client represents and warrants that Client is authorized to bind each owner of the mare to this agreement as if each such owner was the "Client" hereunder and Client acknowledges and agrees that the liability of each owner of the mare under this agreement shall be joint and several.

4. **BREEDING**

A. **Stud Fee:** Client contracts to breed the Mare to Pikhasso++/ AHA 613431 PtHA 124383 (hereinafter the "Stallion") during the 2022 breeding season. The Stud Fee for this breeding shall be \$1,500 for purebred Arabian mares or \$850 for all other mares. A deposit (\$300/\$150) shall constitute a final, irrevocable and non-refundable Booking Fee, payable upon Client's execution of this agreement. The balance of the Stud Fee shall be paid as follows: When mare is checked 45 days in foal or when the mare leaves the premises of KOTA Arabians, whichever occurs first. Client represents and warrants that the Mare shall be suitable for breeding or rebreeding and shall be free of all disease and illness at such time. .

B. **Rebreeding:** If the Mare is bred to the Stallion and fails to produce a "live foal", (defined as a foal that stands, suckles and survives 30 days after birth), We will provide a rebreeding the following breeding season; provided that: (1) the failure to produce a "live foal" is certified in writing by a licensed veterinarian within one (1) week of such determination and that certification is provided to Us within (2) weeks from the determination. The ranch fees shall remain the same.

C. **Transported semen:** The balance of the stud fee must be paid prior to shipment of semen. Mare owner must put us on notice 24 hours in advance, and must order semen by 10:00 am, West Coast time, for same day shipment. We will collect, prepare semen for transport, and ship Fed Ex overnight, Monday through Friday, at a cost of \$300 (will be paid to Willow Hill Equestrian) per collection plus shipping, we will use your FED-EX number if you have one or you may use ours.

Mare owner shall be responsible for obtaining any permits required from breed registries other than AHR and must be in order at the time of collection of semen according to applicable registry rules. Mare owner agrees not to hold us responsible if breed requirements are not met due to improper filing of paperwork by the mare owner. We will handle all permits, payments of fees and filing of documents required by the stallion owner in a timely manner. A Transported Semen Service certificate, required for purebred Arabian foal registration, will be

provided at the time of foaling, provided all service contract monies have been paid.

Option to rebreed: If client ops to breed to Pikhasso++/ the following year, they may do so at a reduced stud fee of \$1250/750 That stud fee will remain the same for each consecutive year the client breeds back. If a year is skipped, this offer is null and void and all prices resume to current costs.
