### TERMS AND CONDITIONS

1. Mare Owner shall pay WHE: \$500.00 (HALF of 2023 stud fee) before Mare is bred to Stallion. Mare Owner shall pay a non-refundable Breeding Shed Fee of \$50.00 for every cover. Mare Owner shall pay WHE \$500.00 (second HALF of 2023 stud fee) as soon as the mare's positive pregnancy check is completed. In the event of mare aborting foal during 2023 season, Mare Owner shall be entitled to a breed back during the 2023 season OR during 2024 breeding season. In the event the mare does not conceive (in 2023), Mare Owner shall be entitled to a breed-back during the 2023 season only with \$500.00 owed to WHE once mare is 30 days in-foal. \*\*\*Breeding season is February 15, 2023 through July 1, 2023\*\*\*

2. Mare Owner must provide WHE documentation of CLEAN uterine culture BEFORE Mare is covered.

3. Mare Owner shall assume all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare whether by death, disease, injury, infection or otherwise, and by any cause whatsoever, including inappropriate, untimely, or negligent insemination or failure of insemination, and therefore releases, discharges, indemnifies and holds harmless Willow Hill Equestrian, Ltd., its employees, agents, officers and directors, from any liability for any and all damages associated therewith. Mare Owner hereby agrees to pay all expenses and attorney's fees incurred by Willow Hill Equestrian, Ltd. in defending any claims for which Mare Owner has agreed to release, discharge, indemnify and hold harmless Willow Hill Equestrian, Ltd., its agents, employees, officers and directors.

This Contract shall be constructed and governed by the laws of Virginia and the parties expressly agree that jurisdiction and venue for any and all disputes arising under this Contract shall be proper only in Orange County, Virginia. In the event that Willow Hill Equestrian, Ltd. incurs attorney's fees and/or legal costs in securing or protecting any right available to it under this Contract or under the laws of Virginia, the Customer agrees to pay said attorney's fees and costs.
